- Handling card replacements when issues arise.

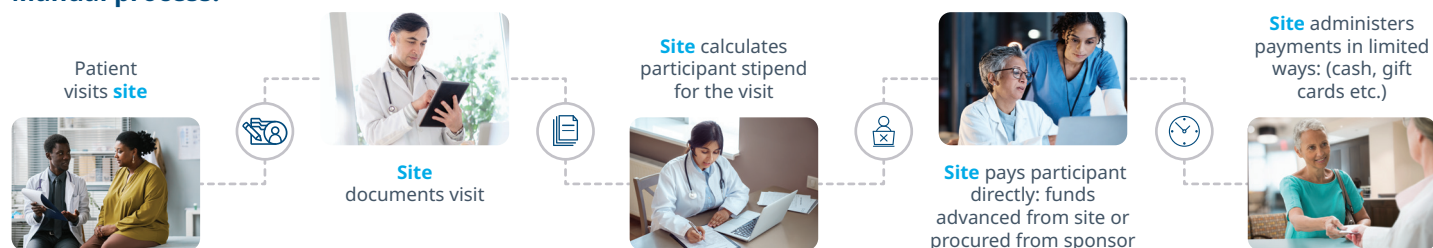

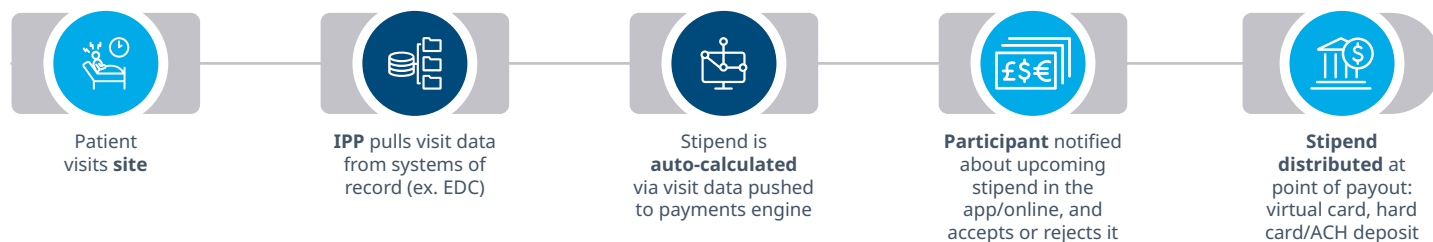
