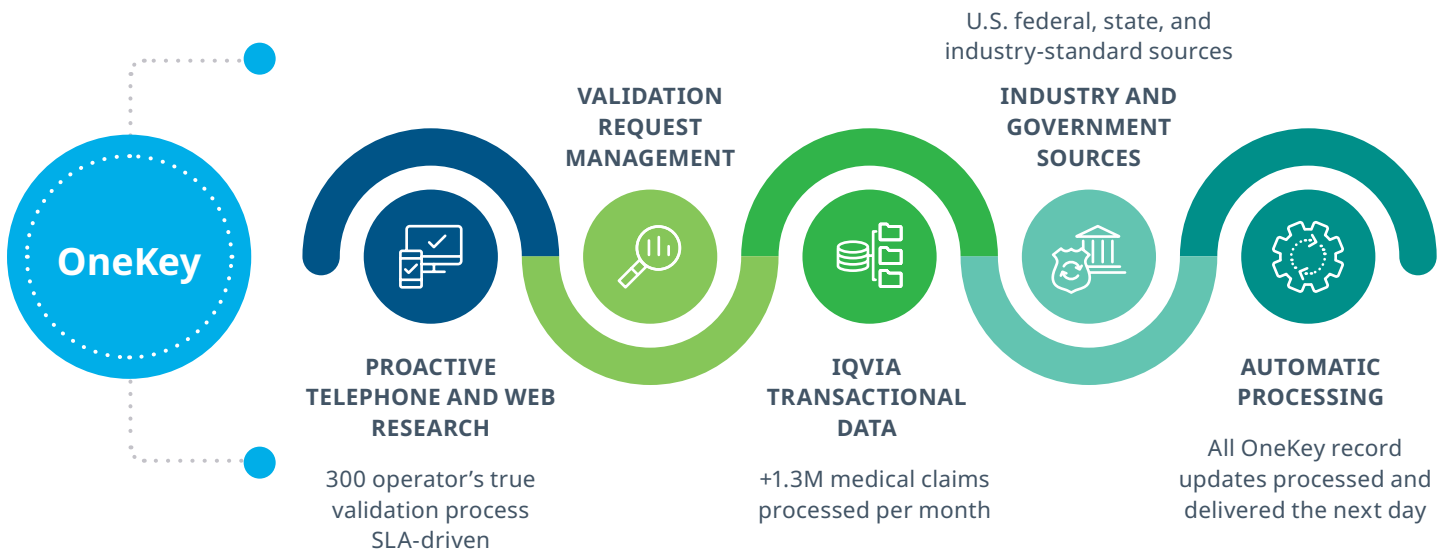

### DSCSA

All trading partners must be authorized. To be authorized, wholesale distributors and third-party logistics providers must be appropriately licensed and report licensure and other information to the FDA annually. OneKey provides email data and state license data for organizations to assist with required annual reporting. OneKey can be the golden record for identity proofing.



### Open Payments

Open Payments is a federally mandated program that collects and publishes information about payments reporting entities make to covered recipients. Reporting entities submit information annually to CMS. OneKey Provides 100% coverage of all federally reportable HCPs and HCOs for open payment. This data is available in real time and includes key data elements such as: NPI, DEA, SLN, and Tax ID.



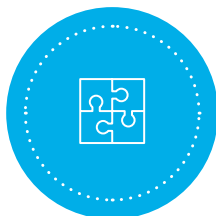
### PDMA

PDMA, in part, regulates the storage, handling, and distribution of prescription drug samples by firms via mail, common carrier, and delivery by representatives to licensed practitioners or pharmacies of hospitals or other healthcare entities. OneKey can help identify practitioners who are eligible to receive samples via OneKey sample eligibility offering. OneKey also provides license verification and address details required for reporting.
